The Computer Hut CC - Terms and Conditions of Service

1.1 These Terms and Conditions to Prevail

These terms and conditions (hereinafter referred to as "this agreement") shall, when read together with the Application Form and any schedule thereto, constitute the whole of the agreement between **The Computer Hut CC reg.no.CK 2009/092539/23 ("TCH")** and the Client.

1.2 Charges

The Computer Hut reserves the right to adjust installation & service charges at their sole discretion. Existing Clients will receive one month's notice relating to service charge adjustments.

1.3 Termination

The agreement shall continue indefinitely and shall **be terminable on the expiry of one calendar month's written notice given by either party to the other**. On termination of a service, **The Computer Hut** will, at its own discretion, buy back any new (less than 6 months old), working radio equipment. **The Computer Hut** will assess the buy-back value and inform the client.

1.4 Client's Obligations

The Client may not at any time use the service in contravention of any South African law. In particular, the Client undertakes to familiarize itself and ensure that it is kept continuously apprised of all South African law, in force from time to time, which has any bearing on the service and/or its use. **The Computer Hut** has no obligation to assist the Client in this regard. Please note that should a client be guilty of excessive use of bandwidth (in excess of 50Gig per calendar month) his service speed will be lowered to the minimum for the rest of that month.

If the problem is not related to the The Computer Hut's network, a minimum fee of R150 per15min will be charged.

Telephonic support for your Internet Connection will be given only for Windows 7 and Windows 8 windows 10 platforms.

Any third-party networking or Internet client or server software will not be supported by The Computer Hut.

The Computer Hut cannot be held liable for any damage to computer equipment during and after installation.

The Computer Hut will only set up your configuration on a Standard Windows Windows 7/8/10 machine running Microsoft Outlook.

The Computer Hut shall not set up a connection on your system if it is running third-party networking or 'firewall' software. If you are unaware of it and we encounter such software during an installation then additional (hourly) charges will apply (including, but not limited to, your system administrator/IT manager's services, as required).

For call-outs involving "connection problems": A minimum call out fee of R200 will be charged. In the event that the fault is due to faulty installation, there will be no extra charge. Faulty hardware will be replaced under warranty (a one-year warranty applies) but an hourly installation

rate of R200 will apply. In the event that the call-out issue is related to your software (including Windows); hardware;

power supply; damage; tampering or user error - service charges will apply including mileage. Charged at R200/hour and R3.50/km respectively.
